OUR COMMITMENT We highly value the trust that You place in Us and We are committed ct the security of Your Personal Data and to ensure that Your rights according to data protection Law are safeguarded.

INFORMATION WE HOLD ABOUT YOU As data controllers. We may collect, store and use the following categories of Personal Dat

- a. Basic Personal Data, such as: Your name and surname; identification document details; date
- of birth; mail address; contact details; banking details; occupation and signature; Information about Your insurance requirements, such as: details about the subject matter to be insured and details about persons to be covered by Our insurance products; Additional information, such as: accident, loss or claims history; creditworthiness; no claims
- bonus; insurance history (including: previous special underwriting conditions imposed and decline of cover); annual income and matters relating to the prevention, detection and/or

suppression of fraud, money laundering and terrorism and Your marketing preferences; We may also collect, store and use the following "special categories" of more sensitive Personal Data, such as: current and past health information; pre-existing health conditions or injuries; medication; medical treatment; surgical procedures; hereditary disease, illness or condition; and smoking or drug abuse history.

HOW WE WILL PROCESS INFORMATION ABOUT YOU We will only process Your Personal ata when the Law allows Us to. Most commonly, We will use Your Personal Data in the following

HOW WE MAY SHARE YOUR PERSONAL DATA We may share Your Personal Data within Our different departments, Our affiliated companies and Our service providers, including assistance and road assistance service providers. This is generally required for the performance of Our contract with You; in order to identify products which may be of interest to You; for pricing and underwriting purposes; for marketing purposes; and for claims management purposes. Moreover, We may share Your Personal Data to prevent, detect and/or suppress fraud and in order to be able to comply with Our legal obligations

We may also record telephone conversations for quality and assurance purposes. Our head office and branches are equipped with CCTV cameras for security purposes.

SECURITY We will take appropriate measures to protect Personal Data and sensitive Personal Data, which are consistent with the applicable privacy and data security Law and regulation including requiring third party service providers to use appropriate measures to protect the confidentiality and security of Personal Data and sensitive Personal Data
